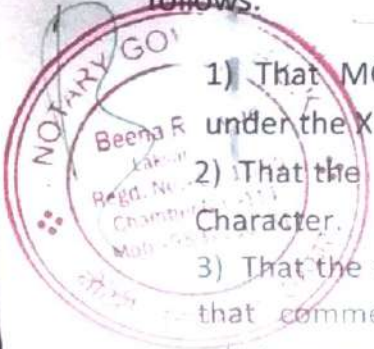

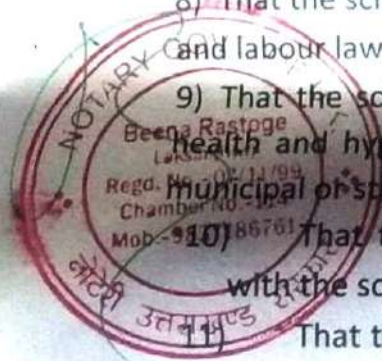
10) That the school will ensure that all required infrastructure is available with the school before starting classes.

14) That the school strives to make efforts for conservation of environment.






